The regular scheduled meeting of the Board of Trustees of Turtlecreek Township was held on March 25, 2014 at 8:00 a.m. with the following person present:

TRUSTEES: Dan Jones and Jim VanDeGrift CHIEF FISCAL OFFICER: Tammy Boggs

GUEST: Steve Flint, Michael Jameson, Larry Wilson, Michael Shaffer and Jennifer Niehaus.

The meeting opened with Mr. Jones leading the Pledge of Allegiance.

Ms. Boggs noted in the minutes that Mr. Jonathan Sams is absent from the meeting.

The minutes of the previous meeting February 10, 2014 and March 10, 2014 were received by the Trustees prior to the meeting for review. Since there were no additions or corrections, Mr.VanDeGrift moved for acceptance, seconded by Mr. Jones. All were in favor and the minutes were approved as written

The Trustees discussed the third appointment to the Warren County Regional Planning Quarterly Board. Mr. VanDeGrift made a motion to appoint Ms. Michele Niewierowski to the quarterly board for regional planning. Mr. Jones seconded the motion. All voiced a "YEA" vote and the motion was passed.

The township received the replat for lots 12 and 13 of Apple Ridge Acres Subdivision for the Trustees to review. The Trustees and Fire Chief have no comments or concerns regarding this replat. A letter will be sent to Warren County Regional Planning regarding this replat.

Mr. Butts, at the last meeting, had questions regarding the bonds for the water that was installed along Hamilton Road. A letter was sent to Mr. Butts explaining that any new properties in the area will be charged a fee and this fee will be placed in the Bond Retirement Fund.

Ms. Boggs informed the Trustees that a quote for the insurance for volunteers was received from VFIS and Provident with similar premiums. The policy with Provident provides better coverage and includes part time employees. The premiums for this policy will be \$5,887.00 for the year. Mr. VanDeGrift made a motion to use Provident Insurance for this insurance policy. Mr. Jones seconded the motion. All voiced a "YEA" vote and the motion was passed.

Mr. Jones signed the conflict of interest letter for Brickler & Eckler regarding the Otterbein development.

Department Reports:

Fire/EMS: Steve Flint, Fire Chief and Mike Jameson, Assistant Fire Chief reported fire and EMS incident information. Chief Flint requested the purchase of new turn out gear for the Fire Department. The approximate cost will be \$6,500.00 from Warren Fire Equipment. Mr. VanDeGrift made a motion to purchase the turn out gear. Mr. Jones seconded the motion. All voiced a "YEA" vote and the motion was passed with **Resolution 14-03-05.** (A copy of the resolution is included in the minutes). Chief Flint followed up with the Warren County Emergency Services and they stated that in a case of emergency they will be able to provide fuel to the township via their pumps or the National Guard.

Road and Bridge: Larry Wilson, Road Supervisor, presented his weekly department activity reports completed since the previous meeting. Mr. Wilson reported to the Trustees that the Road Department is in the process of repairing pot holes in the township.
