The regular scheduled meeting of the Board of Trustees of Turtlecreek Township was held on May 9, 2016 at 7:00 p.m. with the following person present:

The meeting opened with Mr. VanDeGrift leading the Pledge of Allegiance.

The minutes of the previous meeting on 4/26/2016 were received by the Trustees prior to the meeting for review. Since there were no additions or corrections, Mr. Sams moved for acceptance, seconded by Mr. VanDeGrift. All were in favor and the minutes were approved as written.

Department Reports:

Fire/EMS: Steve Flint, Fire Chief, asked the trustees to approve the contract for the new Medical Director, Brian McDonnell. Mr. Sams made a motion seconded by Mr. VanDeGrift to approve the contract for medical director services with Brian McDonnell for \$2,500.00 annually. All present voiced a "YEA" vote and the motion passed with resolution **16-05-01** (a copy of the resolution will be included in the minutes).

Mike Jameson, Asst. Chief, reported that the training in Texas went very well and that he learned a lot during the training.

Road and Bridge: Ron Chasteen, Road Supervisor, informed the board that he had spoken to the Warren County Engineer's Office and gotten approval for a guardrail to be placed on Keever Rd. in the bad curve. Discussion was held regarding the necessity of the guard rail and at this time no motion was made.

Mr. Sams made a motion seconded by Mr. VanDeGrift to accept the 2016 annual resurfacing project with the Warren County Engineer's office and to award bid in the amount of \$292,987.75 to John. R. Jurgensen for resurfacing of the Turtlecreek Subdivision and Kirby Rd. between Hart Rd. and St. Route 48. All present voiced a "YEA" vote and the motion passed with resolution **16-05-02** (a copy of the resolution will be included in the minutes).

Mr. Chasteen informed the board that he would like to repair the catch basin in the Twin Oaks subdivision. Mr. Sams made a motion, seconded by Mr. VanDeGrift to have Tele-Vac Environmental repair the catch basin at a cost of \$1,500.00. All present voiced a "YEA" vote and the motion passed with resolution **16-05-03** (a copy of the resolution will be included in the minutes).

Administration:

Mrs. Boggs, Administrator, informed the trustees that there was a rural zoning request for a bed and breakfast off of Turtlecreek Union Rd. Mr. Sams made a motion, seconded by Mr. VanDeGrift to approve the request on the basis that it is subject to inspection by the township Fire Department. All present voiced a "YEA" vote and the motion passed.

Mrs. Boggs also informed the trustees that the Regional Planning Commission was requesting input on McGowen Acres Phase 2 alterative plat and Charleston Place subdivisions 3rd addition. Mr. Sams made a motion, seconded by Mr. VanDeGrift to respond with no objection regarding the request. All present voiced a "YEA" vote and the motion passed.

RESOLUTION 16-05-01

APPOINTMENT OF MEDICAL DIRECTOR FOR TURTLECREEK TOWNSHIP

WHEREAS, it is a requirement of the Ohio Department of Public Safety, Division of Emergency Medical Service, that an Emergency Medical Service functioning in the State of Ohio retain a Medical Director to oversee the operations of the service; and

WHEREAS, Turtlecreek Township's Emergency Medical Service's existing Medical Director, Dr. Kenneth Patton, (Qualified Emergency Physicians, 774 Cedar Drive, Loveland, Ohio, 45140) has indicated an interest in terminating his association with the Turtlecreek Township Emergency Medical Service due to his other commitments; and

WHEREAS, Dr. Brian McDonnell, (920 Riverview Place, Cincinnati, Ohio, 45202) has indicated an interest in becoming the Medical Director of the Turtlecreek Township Emergency Medical Service, by signing the Turtlecreek Township's EMS Drug License, effective June 1, 2016; and

NOW, THEREFORE, BE IT RESOLVED, the Turtlecreek Township Board of Trustees hereby appoints Dr. Brian McDonnell to serve as the Medical Director of the Turtlecreek Township Emergency Medical Service, and further agrees to pay Dr. Brian McDonnell the sum of \$2,500 annually beginning June 1, 2016 for his professional services. An annual payment will be made at the end of each year with the first year being prorated. Said services shall continue for an undetermined length of time, or until such time as a new professional fees is negotiated by both parties. This contract shall remain in effect until such time as either arty wishes to terminate same. Should either party wish to terminate the contract, a 90-day written termination notice shall be required in order to allow for a new medical director to be found. Dr. Brian McDonnell services, Review and Approval of all Protocols, Review of Run Sheets, and may include occasional Training Sessions, and other services as may be agreed upon by the Turtlecreek Township EMS Chief and Dr. McDonnell.

FURTHER, BE IT RESOLVED, to enter into a contract with Dr. Brian McDonnell for said medical direction and services, a copy of which is made a part of this resolution. This resolution was introduced by Mr. Sams and seconded by Mr. VanDeGrift. All voiced a "YEA" vote and the resolution passed.
